- ENTRY DEADLINE:** \$40 Late fee will be added to any entry after **Saturday, January 31<sup>st</sup> 11:59 p.m.**  
**Registration closes Monday, February 2<sup>nd</sup> 11:59 p.m.**
- ELIGIBILITY:** **U14** - All participants must hold a current Alpine Competitor membership with US Ski and Snowboard. No on-site registration. No additions will be made after close of registration. No refunds after the close of the TCM.
- LIFT TICKETS:** Racer tickets – U14 \$40, Family Tickets (Age 6-12) \$35, (Age 13-69) \$85, (Age 70+) \$75  
**4 day Racer ONLY lift tickets can be purchased in advance by clicking on this link:**  
<https://shop.skichinapeak.com/far-west-race> Please select Event Date: 2/5/26 when purchasing. **To pick up your advanced purchased racer lift tickets, please go the Kiosk located in Mainstream Station Lodge and scan the QR code.** Should you need a lift ticket that is not 4 days or purchasing family lift tickets, please go to the ticket window by Chair 1 to purchase for the days needed.  
\*Tip: Please have lift tickets placed on the left side of jackets by itself to help expedite chair loading process\*
- REGISTRATION:** Check – in 7:30 a.m. Thursday - Sunday in the Mainstream Station Lodge
- RELEASE OF LIABILITY:** **All racers must complete and sign a LIABILITY RELEASE in order to compete in the event. Release of Liability waivers must be completed during purchase of lift tickets from the mountain. Lift ticket will be blocked if not completed and not allowed to compete in the event.**
- BIBS:** Bibs will be issued to a Team Captain at the morning of Training Run at the Mainstream Lodge 7:30 a.m. Bibs will be held for any athlete that does not complete a Release of Liability waiver. Teams will be charged \$50 for any unreturned bibs.
- TEAM CAPTAIN'S MEETING:** Wednesday, February 4<sup>th</sup> – 6 p.m., Location: China Peak Race Team Office (located next Ski Patrol building) For people not able to attend in person, Zoom link will be sent to all registered coaches and officials.
- RACE LOCATION:** SG – Upper Razorback/Middle Razorback/Jack's Run – Athletes load Chair 1
- RACE SCHEDULE:** Start time 10 a.m., February 5<sup>th</sup> - SG TR, February 6<sup>th</sup> – 8<sup>th</sup> – 3 SG Men & Ladies

- PARKING:** Drive past the preferred parking lots and park in the back parking lots which will be located closest to Mainstream Station Lodge and Chair 1.
- AWARDS:** Approximately 1 hour after the close of the protest period on Sunday for all 3 SG races in the Mainstream Station Lodge
