

# CRYSTAL MOUNTAIN ALPINE CLUB LIABILITY RELEASE

## Please read carefully; involves the release and waiver of legal rights

1. I am aware that skiing and snowboarding are hazardous activities that include numerous risks and dangers, including the risk of serious injury or death, and that competitions and race, strength and endurance training, as well as coaching, officiating, assisting and volunteering in connection therewith (collectively the "Activities") involve additional risks and dangers beyond those of general skiing/snowboarding. **I voluntarily accept full responsibility for all of the risks and dangers involved, including, but not limited to, the above and all other risks inherent in skiing, snowboarding and the ski/mountain resort environment, such as encountering or using vehicles, encountering adverse snow and ice conditions including avalanches or snow immersion and notwithstanding such risks voluntarily choose to take part in the Activities.**

2. I accept responsibility to maintain control at all times, to abide by the Skier Responsibility Code, and to obey all posted signs, warnings and other notices and any other ski area rules and policies. Any equipment I use while skiing or snowboarding, including but not limited to the lifts, I use at my own risk. I understand that while participating in the Activities I may have my access to the resort suspended or revoked for behavior inconsistent with the policies of Crystal Mountain.

3. In consideration of acceptance of my enrollment in Crystal Mountain Alpine Club (CMAC), and/or my participation in any CMAC sponsored event at Crystal Mountain, I agree that I will not sue or make claims against CMAC, Crystal Mountain, Inc., Alterra Mountain Company, the U.S. Forest Service, the US National Park Service or any of (their/its) affiliates, employees, agents contractors, subsidiaries, shareholders, members, managers, directors, officers and volunteers (the "Released Parties") for any loss, injury or damage resulting from any cause whatsoever including but not limited to the negligence of any Released Parties, which arises out of or relates to my participation in CMAC or any CMAC-sponsored event, skiing/riding at Crystal Mountain and the use of the facilities of Crystal Mountain or travel to and from Crystal Mountain or other locations.

4. I agree to ASSUME ALL RISKS AND WAIVE, RELEASE, HOLD HARMLESS, DEFEND and INDEMNIFY the Released Parties from and against any and all loss, injury or damage which arises out of my participation in the above referenced activities and all other uses for any purpose of the facilities of Crystal Mountain resort. This release is also binding as to any other person, including all family members, heirs, executors and any minor who accompanies me.

5. I am over 18 years of age and/or my legal guardian has also read and signed this release below. I am in good health and capable of participating in the Activities. I consent to medical care being provided and transport to a medical facility if in the opinion of resort personnel such care is needed and agree to pay for all costs of such medical care.

6. If I am signing on behalf of a minor(s), I accept full responsibility for all medical expenses incurred as a result of the minor's participation in the above activities and or travel to and from Crystal Mountain. I agree to HOLD HARMLESS, DEFEND and INDEMNIFY the Released Parties for any losses or claims involving the minor.

7. I agree that all claims that may arise from my participation in the above activities shall be governed by the laws of the State of Washington and the courts of the State of Washington shall have exclusive jurisdiction over all such claims. I HAVE CAREFULLY READ THIS RELEASE OF LIABILITY, FULLY UNDERSTAND ITS CONTENTS AND SIGN IT OF MY OWN FREE WILL.
