RELEASE OF LIABILITY, ACKNOWLEDGEMENT OF RISKS, AND CONSENT AGREEMENT

THIS IS A LEGALLY BINDING AGREEMENT. PLEASE READ CAREFULLY BEFORE SIGNING

As a participant in the **2026** Park City Ski & Snowboard ("PCSS") Town Series, Ski the Peak, Spring Carnival, High School Exhibition Race, and or PCSS training sessions in preparation for these events ("the Event"), I expressly agree to assume any and all risks of injury, including the risk of serious injury and even death, in connection with my participation in the Event, regardless of the cause of injury, the activity, or the date on which the injury is allegedly sustained.

I acknowledge and understand that obeying and following safety rules and or instructions during my participation in the Event or related training sessions does not guarantee my safety. I understand that my safety is not guaranteed in any manner.

I further agree to forever release Park City Ski & Snowboard, and its respective affiliates, related entities, employees, officers, directors, agents, volunteers, landlords, property owners, and the facilities or venues where the Event is held, from any and all liability. I also agree to forever waive any and all claims, causes of action, charges, damages, and demands of any kind whatsoever, including for injuries I may sustain while participating in the Event or related training sessions as a result of the negligence of PCSS.

I understand that participation in the Event and related training sessions is inherently risky and dangerous. I acknowledge that conditions may include variable snow surfaces, uneven or unlit terrain, weather conditions, and other natural or man-made hazards. I represent that I possess the skill level and experience necessary to safely participate in the Event or any training sessions I elect to take part in.

I hereby consent to allow PCSS staff, volunteers, and or ski patrol personnel to administer first aid and or emergency medical treatment to me for any injury or illness that occurs during my participation.

I have read and understand this Agreement and voluntarily enter into it without reservation. I agree that I am participating on a purely voluntary basis. I acknowledge that no representations have been made to me other than those expressly contained herein.

If any portion of this Agreement is found unenforceable, the remaining portions shall remain in full force and effect. I agree that any disputes or claims shall be governed by the laws of the State of Utah and resolved exclusively in the Third Judicial District Court of the State of Utah.

This Agreement applies to my participation on all days the Event and or related training sessions are held, whether consecutive or non-consecutive.
